## 2011 Spring Trial Updates (<http://www.nstra.org/midwest.htm>)

### New Business:

- Anyone interested in running in the NSTRA Performance Classic please enter your dog with national for this trial. They have 80 some dogs entered as of today. Your dog is eligible to run even if it has one point earned from March 1, 2010 to Feb. 28, 2011. This trial was a huge success last year and it is a rare opportunity to trial with some of the best dogs and handlers this close to home.
  - **Qualification:** Points earned from March 1, 2010 through February 28, 2011. All points will count except those points earned during qualifying and final rounds of the National Championship and Regional Championship Trials. In case of a tie in points, the tiebreaker will be date of entry. Watch for the entry form in the Feb/Mar issue of the NSTRA magazine and online. Entries will open on February 1, 2011. Deadline for entries will be March 31, 2011.
  - The trial format will consist of 64 to 128 dogs. Wednesday and Thursday's qualifying rounds will be beat your brace-mate . Friday's round will be the top 8 scoring dogs from each field with a return to beat your brace-mate for the final round on Saturday.
